Legal basis of the treatment of important information

This site deals with data mainly based on user consent. The consent is given by the banner at the bottom of the page, or through the use or consultation of the site, as a conclusive behavior. With the use or consultation of the site, visitors and users approve this privacy statement and consent to the processing of their personal data in relation to the methods and purposes described below, including any disclosure to third parties if necessary for the provision of a service. Through the communication or service request forms further consents are collected relative to the specific purpose of the service.

The provision of data and therefore consent to the collection and processing of data is optional, the User can deny consent, and can revoke consent already given at any time (via the banner at the bottom of the page or the browser settings for cookies, or the Contacts link). However, denying consent may make it impossible to provide certain services and the browsing experience on the site would be compromised.

The data for site security and for the prevention of abuse and SPAM, as well as the data for the analysis of site traffic (statistics) in aggregate form, are treated on the legitimate interest of the Data Controller for the protection of the site and of the users themselves. In such cases the user always has the right to object to the processing of data (see par. [Rights of the user](#)).

Purpose of the processing

use of information

The processing of data collected by the site, in addition to the related purposes, instrumental and necessary for the provision of the service, is aimed at the following purposes:

– **Statistics (analysis)**

Collection of data and information in an exclusively aggregated and anonymous form in order to verify the correct functioning of the site. None of this information is related to the natural person-user of the site, and does not allow identification in any way. No consent is required.

– **Safety**

Collection of data and information in order to protect the site's security (spam filters, firewalls, virus detection) and Users and to prevent or expose fraud or abuse of the website. The data is automatically recorded and may also include personal data (IP address) that could be used, in compliance with the laws in force on the subject, in order to block attempts to damage the site or cause damage to other users, or in any case harmful activities or constituting a crime. These data are never used for identifying or profiling the User and are periodically deleted. No consent is required.

- **Extra activities**

Communicate the data to third parties that perform functions necessary or instrumental to the operation of the service (ex. Comments box), and to allow third parties to carry out technical, logistic and other activities on our behalf. The suppliers have access only to the personal data that

are necessary to carry out their duties, and they undertake not to use the data for other purposes, and are required to process the personal data in compliance with the regulations in force.

Collected data

information collected

This site collects user data in two ways:

1.Data collected automatically

During Users' browsing the following information can be collected and stored in the server's log files (hosting) of the site:

- internet protocol (IP)
- browser
- parameters of the device used to connect to the site;
- internet service provider's name (ISP);
- date and time of visit
- web page of the visitor's origin (referral) and exit
- number of click.

This data is used for statistical and analysis purposes, in an exclusively aggregated form.

The IP address is used exclusively for security purposes and is not cross-referenced with any other data.

2. Data provided voluntarily

The site may collect other data in the event of voluntary use of services by users, such as commenting, communication services (contact forms, comments box), and will be used exclusively for the provision of the requested service:

- e-mail address

The data collected by the site are processed at the Data Controller headquarters, and at the data center (insight.ly), which is responsible for processing the data, processing the data on behalf of the owner, is located in the European Economic Area and acts in compliance with European standards.

Data retention period

The data collected by the site during its operation are kept for the time strictly necessary to carry out the specified activities. Upon expiration, the data will be deleted or anonymized, unless there are no further purposes for their preservation.

The data (IP address) used for site security purposes (blocking attempts to damage the site) is kept for 30 days.

The data for analytics purposes (statistics) are stored in aggregate form for 24 months.

Transfer of collected data to third parties

The data collected by the site are generally not supplied to third parties, except in specific cases: legitimate request by the judicial authority and only in the cases provided for by law; if it is necessary for the provision of a specific service requested by the User; for performing security checks or site optimization.

Data transfer to countries outside the EU important information

This site may share some of the data collected with services located outside the European Union area. In particular with Google, Facebook and Microsoft (LinkedIn) through social plugins and the Google Analytics service. The transfer is authorized based on specific decisions of the European Union and the Guarantor for the protection of personal data, in particular decision 1250/2016 ([Privacy Shield](#)), therefore no further consent is required. Cookie

Cookies allow us to store information on visitors' preferences, are used to verify the correct functioning of the site and to improve its functionality by customizing the content of the pages based on the type of browser used, or to simplify navigation by automating the procedures (eg Login, site language), and finally for the analysis of the use of the site by visitors.

This site uses the following categories of cookies:

- technical cookies, used for the sole purpose of carrying out the transmission of an electronic communication, to guarantee the correct display of the site and navigation within it. Moreover, they allow to distinguish between the various connected users in order to provide a requested service to the right user (Login), and for site security reasons. Some of these cookies are deleted when the browser is closed (session cookies), others have a longer duration (such as the cookie required to retain the user's consent in relation to the use of cookies, which lasts 1 year). No consent is required for these cookies.
- analysis cookies, used directly by the site manager to collect information, in aggregate form, on the number of users and how they visit the site. They are similar to technical cookies if the service is anonymized.

- profiling and marketing cookies, used exclusively by third parties other than the owner of this site to collect information on user behavior while browsing, and on consumer interests and habits, also in order to provide personalized advertising

Important informations

By clicking OK on the banner present at the first access to the site or browsing the site, the visitor expressly consents to the use of cookies and similar technologies, and in particular to the registration of these cookies on his terminal for the purposes indicated above, or upon access through cookies to information on your terminal.

Disabling cookies choices and obligations

The user can refuse the use of cookies and at any time he can revoke an already given consent. Since cookies are connected to the browser used, **THEY CAN BE DISABLED DIRECTLY FROM THE BROWSER**, thus refusing / revoking the consent to the use of cookies, or through the banner at the bottom of the page.

DISABLING COOKIES MAY PREVENT THE CORRECT USE OF SOME FUNCTIONS OF THE SAME SITE, in particular the services provided by third parties may not be accessible, and therefore may not be viewable:

They are treated in aggregate form and anonymized (truncated to the last octet). On the basis of a specific agreement, Google Inc. is prohibited from crossing such data with that obtained from other services.

For the videos on the site the "advanced privacy (no cookie)" option has been activated, which ensures that YouTube does not store information about visitors unless they voluntarily reproduce the video.

Collected data: number and behavior of users of the service, IP address, information linking visits to the site to the Google account for users already logged in, preferences for viewing videos.

Choices and obligations
